Terms of Distribution

Approval Process for Distributors

As a requirement of distribution, all Distributors **must** have a functional retail space and/or website where product can be sold and marketed appropriately, and are required to hold a valid business license in your state/province/country. It typically takes 3-7 (three to seven) business days to receive a denial or approval. Once approved, Distributors will receive a special Distributors Price List for all products offered through Brink Consulting Group (herein known as **BCG**) and access to approved marketing materials, graphics, emblems, and videos. Distributors will receive special offers from us and/or our business partners up to 2 (two) times per year.

Marketing and Sales of Product

Companies and other entities that agree and are accepted as a Distributor may use any of our approved logos, graphics, and emblems for their websites and/or for their entities marketing materials, however, **trade name of BrinkZone™, Internet-Publications.net, and/or Will Brink must be used prominently in all marketing materials when referencing our products for sale.**

Any company or entity that signs to become a Distributor of **BCG** agrees to enter into a non-compete clause with us, meaning that you may not produce any product that is in direct competition with us while you are selling our products.

As a Distributor of **BCG** products **you may not under any circumstances;**

- Create or recreate in whole or in part any portions of distributed materials or products.
- Make claims of ownership of any materials or products, nor, claim full or partial authorship or any book or product distributed through us.
- Reprint books and/or articles by any means without prior written authorization or permission.
- Recreate or change any copyrighted logos, emblems, graphics, videos, or official **BCG** literature.
- Use unapproved logos emblems, graphics, or videos that are a misrepresentation of **BCG** related products.
- Misrepresent or make false claims about any of the book or product procured through **BCG** for sale and what is written therein.
- Resell any **BCG** book through distribution for more than 20% off List Price on any website.

Making Orders

BCG will be emailed or called with any orders, and all orders will be processed in 3(three) business days, excluding any major US holidays. If because of any inventory issues and **BCG** cannot ship; the Distributor will be notified immediately of any delays. All orders should reference a Purchase Order Number and be secure emailed or faxed to:

Purchase Orders should reference payment method if you do not have one on file with us. We accept payment via all major credit cards, and Paypal. Paypal will incur a 3% charge.

Holding Stock

Distributors must have the ability to hold stock at their location. **BCG** does not under any circumstances drop ship to your customers.

Payment Terms and Volume Discounts

Distributors in our program will receive our Distribution Price List 2 times a year.

All orders without special terms: **NET 0 DAYS** and payment is due at the time of purchase.

Payment terms is determined at our discretion and terms other than what is written herein is extended by our Distribution Desk to Distributors that consistently make high volume sales for 6 or more months.

Minimum orders for all Distributors is 10 units.

Please see below for the following minimum and maximum order for each volume discount stage. Volume discount is for the entire order **and is not per unit**;

- ❖ when Distributor orders between 10 - 25 units no volume discount
- ❖ when Distributor orders between 26 - 75 units 5% volume discount
- ❖ when Distributor orders between 76 - 100 units 10% volume discount
- ❖ when Distributor orders between 101 - 200 units 15% volume discount

Orders of over 200 units will receive special pricing

Shipping

Order totals do not include shipping. Prior to your order being shipped, you will be informed as to the shipping cost to your location by the Distribution Desk via email. Orders are always shipped out via the lowest possible shipping. Should you require expedited or higher rate shipping please contact the Distribution Desk.

International shipping is determined by location and you will be required to pay all tax and or duty fees into your country. **BCG** does not and will not at any time pay tax or duties on your behalf.

Return Policy

BGC does not accept returns older than 10 (ten) business days unless there are extenuating circumstances.

Damage that happens during shipment should be reported within 48(forty-eight) hours of being received in ordered to be covered by our return policy. Before returning any materials please contact the Distribution Desk for an RMA#.
